By using this App or by registering Your profile with Zuppit You are giving consent to the collection, transfer, storage, disclosure and other uses of Your information as set out in this Privacy Policy.

This Privacy Policy does not apply to the practises of third parties that Zuppit does not own, control, or manage including but not limited to any third party websites, services, applications, or businesses ("Third Party Services") Zuppit does not take responsibility for the content or privacy policies of those Third Party services. Zuppit encourages You to carefully review the privacy policies of all Third Party Services You access.

a) Personal Information

B.ELIGIBILITY
